By creating safe and supportive schools and building the capacity of school staff, CBHM helps to address barriers to learning. Critical components of CBHM include MTSS as a framework for student support, workforce development, integrated partnerships, universal screening, and evidence-based interventions.

Grant Description & Purpose	Description: The funding provided by the Barr Foundation helped move BINcA 3.0 forward in important ways during the 2023-2024 school year and our vision for success is to build on the momentum and arrive at concrete benchmarks by the end of the two-year grant cycle. We intend to maintain the priority areas from the first proposal and add one new element. The three focus areas from last year are each long-term endeavors and we are only part way there: Innovating and Deepening our Model, Revisioning and Strengthening our Primary Person Model/Advisory, and Rigor Through Project Based Learning and Innovation. In addition, we will add an element called Centering Students and Families as Community Assets. Our vision of success for the next two-year cycle is for an engaged and curious team of educators to continue to learn how best to support our students and families. In this last year, we dramatically increased our interaction with the Internationals Network, and with the support of this funding, we will have an official designation within the Internationals Network by July 1, 2026. The support will also lead to continued refinement, improvement, and eventually expansion of our Primary Person Model. The next two years will include a continued shift to authentic tasks and projects which are rigorous and alligned to standards. And finally, our vision of success centers students and families as assets in our community making contributions to the school community and beyond. In summary, our elevator pitch is that BINcA is transforming our school community to center the assets of students and families. We are partnering with the Internationals Network to ensure that our community can benefit from decades of similar work in a well-developed network. Our diverse team of educators are equipping our students to solve the problems of today and tomorrow. This grant will pay for: Professional Development with the Internationals Network. Teacher Stipends for committee work. Innovative programming for students and families.
Desired Outcomes	1: Integration into the Internationals Network

	BINcA will continue to deepen our relationship with the Interschools Network with the objective of integrating best practices into our school's instructional model. The integration will be guided by a team of staff who will develop a plan for integration into the Internationals Network and will develop staff and community-facing materials that describe the integrations. The team will have a draft plan ready to present to the Instructional Leadership Team and School Site Council by January 2025. 2: Even as this is largely a planning year for a new advisory program, we expect to see results from changes in the short time with even stronger results when a new system is fully implemented. With the first phase of changes to our advisory program, we expect to see improvement in two key measures; chronic absenteeism and sense of belonging. We expect to reduce our chronic absenteeism rate from 41% to 31% and increase our average daily attendance from 87% to 91% by the end of the 2023-2024 school year. We also expect to see an increase in the sense of belonging from 44% to 50%. 3: The focus on rigor will be monitored and implemented in planning and instruction. Throughout the year beginning with the August Institute, Content Planning Teams
	and Grade Level Teams will use a PBL unit review process to build a shared understanding of rigorous units. We will use the Hess Matrix as a model for ensuring that tasks are rigorous. The review work will be evidenced in CPT and GLT rolling agendas and reflected in our Master PBL Planning Document.
